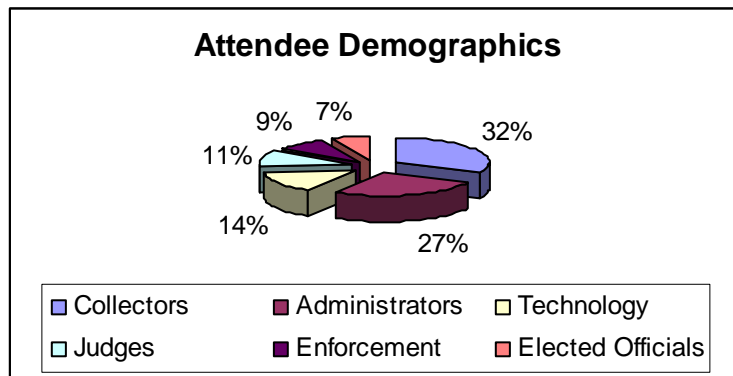

Overview

The *National Court Collections Conference* is a two day event with multiple sessions focusing on improving court collections and compliance, increasing governmental revenues, and examining cutting edge collections technologies. It is the only national conference devoted exclusively to judicial collections. The 2009 conference was the first under the sponsorship of the *National Governmental Collectors Association* drew nearly 200 attendees representing 27 states and governments from Arizona to the Virgin Islands in the worst economy in 80 years. The 2010 event has the potential to be the largest in its brief history. The conference will feature expansion of the targeted attendance base of judicial collections to include local ordinances, probation, parole, law enforcement, utilities, child support, and student loans. Projections estimate attendance at this conference could exceed 300. Court and governmental collections has become multi-billion dollar industry with municipal governments alone generating a staggering \$1.25 trillion in revenue annually. This will not be the traditional tradeshow styled event. Participating vendors will not compete with hundreds of other vendors for the attention of potential clients. Vendors will have the opportunity to meet and talk with hundreds of prospective clients in a superior business setting as well as showcase their offerings through an exclusive Exhibitor's Hour, Product Theater's, and standard vendor exhibitions. To ensure a highly focused and personal event, vendor participation will be restricted to a limited number of highly specialized companies.

Attendees are people with court collection responsibility: city, county, and state officials including state administrators, county commissioners and supervisors, county and district clerks, city managers, municipal court clerks, treasurers, auditors, finance managers, and law enforcement personnel interested in a source of additional revenue; judges seeking a higher degree of court-ordered compliance; court managers, collectors, information technology specialist, and administrators in search of improved fine and costs collections.

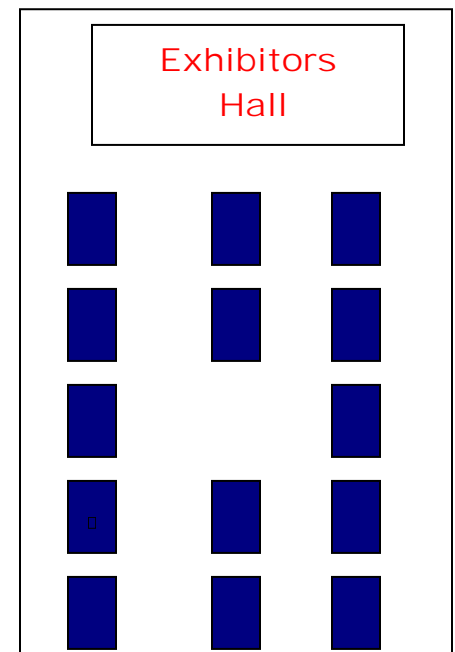
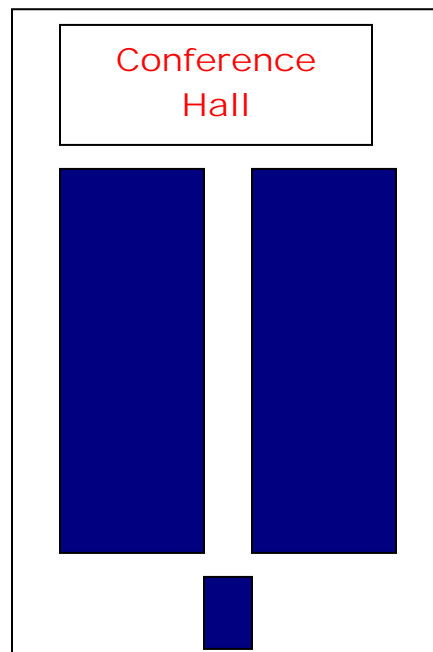
